



terms and conditions, as may be deemed advisable and in particular by the issue of bonds, debentures, bills of exchange, promissory notes, or by mortgage or charge of all or any part of the immovable or movable assets belonging to the TRUST.

- XX. To establish and support or aid in the establishment or support of funds, trusts or institutions, calculated to benefit the employees or ex-employees (or their dependant's) of the TRUST or any institution's maintained by it.
- XXI. For the benefit of the TRUST, to become member of any other body or bodies of persons, associations of persons, intuitions, societies, and bodies corporate, including companies limited by Guarantee.
- XXII. To do all such other lawful things as may be incidental or proactive to the attainment of the objects of the TRUST.

The Trustees shall each year, cause to be made and prepared all proper accounts of receipts and expenditure in connection with the management of the TRUST FUND and other institution/s for the proceeding year, showing separately several heads of receipts expenditure.

The accounts of the TRUST FUND and its institution/s shall be maintained on FINANCIAL YEAR BASIS, i.e. commencing from the 1st April and ending on 31st day of March, and shall be audited by CHARTERED ACCOUNTANT, every year.

- e) Notes made in the Minute Book and other heads of any matters relating to TRUST shall be conclusive evidence of the facts and matters duly noted therein.
