- VI. For setting up or helping by endowments or otherwise, orphanages or poor, houses for the benefits of orphans and or other deserving persons.
- VII. In helping of poor Widows.
- VIII. To establish or render help to any institutions for the alleviation of human suffering.
- IX. To subscribe, contribute and or donate to any public charitable trusts or funds or institution for promotion of any of the aforesaid objects.
- X. 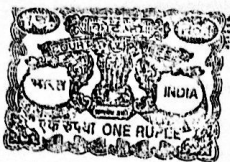

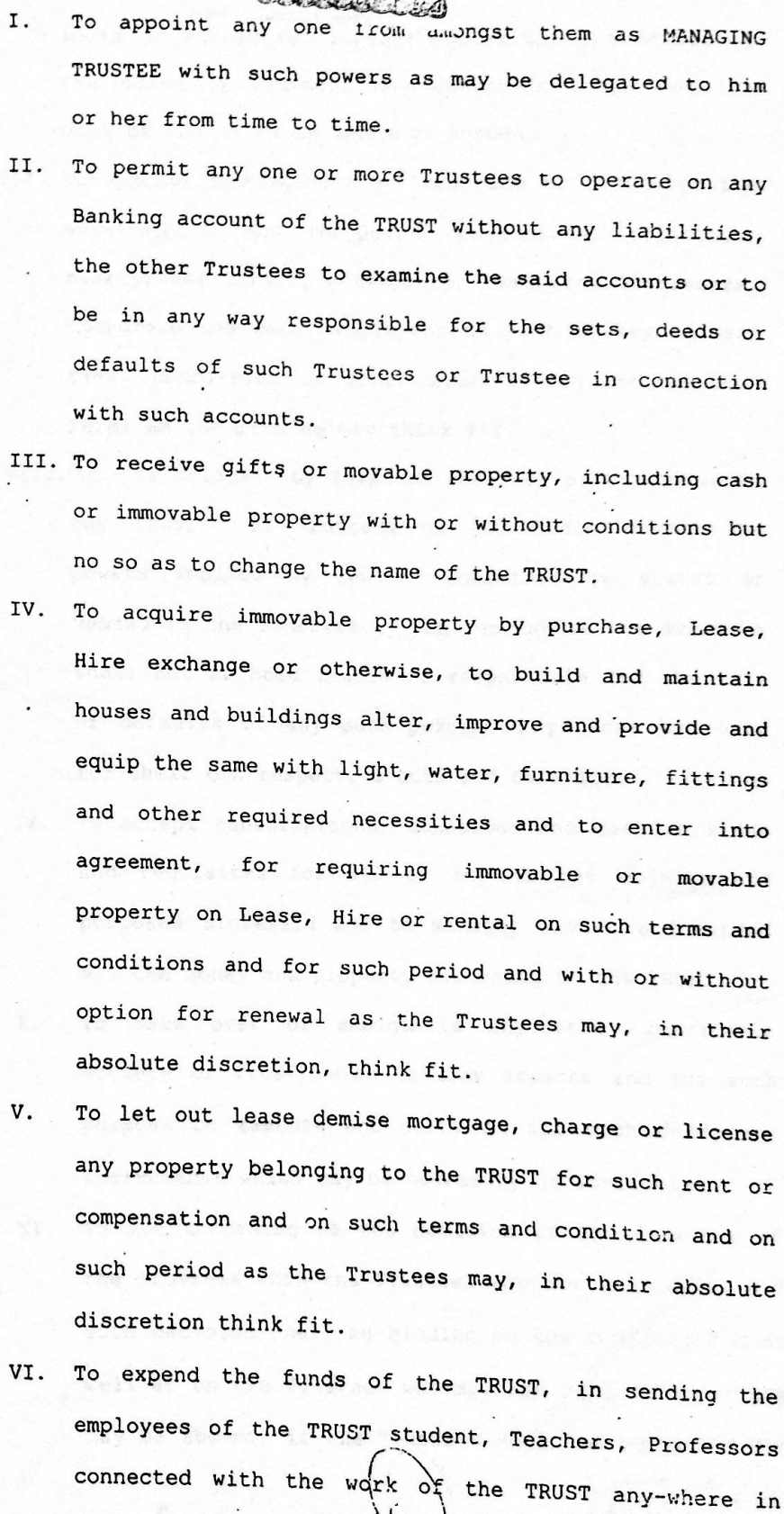

VII. 

XII. To remorse themselves or pay and discharge out of the TRUST FUNDS or any property subjects to the trust of these presents the income thereof and the expenses that may be incurred for about the execution of the Trust and power of these presents including reasonable amount of traveling expenditure, incurred for attending the meeting of the Trustees.



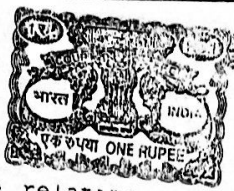

expenditure relating to the TRUST FUND and any other institution/s maintained by it, shall be entered and recorded and such books shall be kept at the Trust or such institution/s as the case may be.

The Trustees shall each year, cause to be made and prepared all proper accounts of receipts and expenditure in connection with the management of the TRUST FUND and other institution/s for the proceeding year, showing separately several heads of receipts expenditure.

The accounts of the TRUST FUND and its institution/s shall be maintained on FINANCIAL YEAR BASIS, i.e. commencing from the 1st April and ending on 31st day of March, and shall be audited by CHARTERED ACCOUNTANT, every year.

- e) Notes made in the Minute Book and other heads of any matters relating to TRUST shall be conclusive evidence of the facts and matters duly noted therein.

4. Any Trustee (other than the SETTLOR) being lawyer, accountant or other person engaged in any profession or business, shall be entitled to be paid as usual professional or proper charges for the time expended, business transacted and acts done by him or any partner of his, in connection with the trusts hereof (including acts which a Trustee not being in any profession or business could have done personally) in spite of the fact that he shall be a Trustee of these presents.

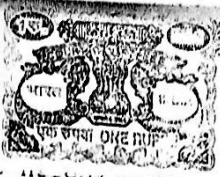

15.
